Session Agreement

Scope of Service

- QHHT is a hypnotherapy technique developed by Dolores Cannon. It is designed to access the client's Higher Self to obtain answers and facilitate healing.
- The Quantum Healing Session is a holistic and spiritual wellness service that aims to facilitate inner transformation and emotional well-being. During the session, the practitioner will employ various techniques, including guided meditation, energy healing, and visualization, to help clients explore and address their physical, emotional, mental, and spiritual challenges.
- Past Life Regressions aim to provide a safe and transformative experience, allowing clients to explore their past lives and gain a deeper understanding of their present life's purpose and lessons.
- A Soul Speak Session is a transformative experience developed by Julia Canon. It is designed to empower individuals to connect with their body, inner selves, explore the root causes of physical discomfort, emotional traumas, and energy blocks, and promote self-healing and personal growth.
- None of the above mentioned techniques are medical or psychological treatments.

Eligibility and Age Requirement

- I typically work with clients who are 18 years of age or older.
- If a client is under the age of 18, an exception may be made, but only with the written consent of their parent or guardian.
- Those under the age of 18 may attend a group past life regression or group quantum healing session, but they must have their parent or guardian present throughout the session.
- All clients, regardless of age, should be of sound mind.

Confidentiality and Recording

- All information shared during sessions will be kept strictly confidential, unless the client provides explicit written consent to share specific details or unless required by law.
- QHHT Sessions are recorded for the benefit of the client. The client will receive a copy of the recording. Redistribution or commercial use of the recordings without explicit permission is prohibited.
- I will retain a copy of the session recording for a limited duration, typically between 1 to 2 months, in case the client misplaces their copy. After this period, the recording will be deleted.
- You have the option to record your quantum healing, past life regression or soul speak session, using your mobile phone or audio recording device, if you choose.

- While utmost care is taken to ensure privacy, I reserve the right to share non-identifying insights, experiences, or generalized information derived from sessions on my social media, with other clients, or in a classroom setting. At no point will specific personal or identifying details of the client be disclosed in such instances.

Session Duration

- QHHT sessions last between 4-6 hours. However, individual session lengths can vary. Please allocate sufficient time for your session.
- Soul Speak, Quantum Healing, or Past Life Regression Sessions typically last 60-90 minutes.

Payment and Cancellation Policy

For QHHT Sessions

- Payment is due at the time of service.
- If you need to cancel or reschedule your session, please provide at least 48 hours notice.
- Clients who do not show up or confirm their session and wish to reschedule at any future date will be required to pay a \$100 non-refundable deposit to secure their next session.
- Clients who reschedule more than 2 consecutive times will be subject to a \$100 non-refundable fee to secure their next appointment.
- These fees will be applied to their session fee, but will not be refunded in the event of another cancellation or rescheduling.
- No refunds will be issued after the completion of a session.

For Quantum Healing, Past Life Regression and Soul Speak Sessions

- Payment is due at time of booking. If I need to cancel the session for any reason, a full refund will be issued. If you need to cancel a session and provide at least 48 hours notice, a refund minus processing fees will be issued. If less than 48 hours notice is given, you will be charged a \$50 fee. Clients are allowed to reschedule a session twice, provided a minimum of 48 hours' notice is given and the rescheduled appointment falls within 60 days of the original appointment.
- No refunds will be issued after the completion of a session.
